# **Registration Information**

I. Programs and Tuition: The following programs will be offered subject to enrollment:

For 2 Year Old Program (Tiny Tots): (Child must be 2 years old by December 1, 2020)

2-Day Program: \$50.00 Registration Fee + \$175.00 September Deposit = \$225.00 due at Registration

Tues / Thurs 9:30 - 11:30 am \$175.00 per month Tues / Thurs 12:00 - 2:00 pm \$175.00 per month

For 3 Year Old Program: (Child must be 3 years old by December 1, 2020)

2-Day Program: \$85.00 Registration Fee + \$210.00 September Deposit = \$295.00 due at Registration

Tues / Thurs 9:30 am – 12:00 noon \$210.00 per month Tues / Thurs 1:00 – 3:30 pm \$210.00 per month

3-Day Program - \$85.00 registration fee + \$260.00 September Deposit = \$345.00 due at Registration

Tues / Wed /Thurs 1:00 – 3:30 pm \$260.00 per month

**For 4 Year Old Program:** (Child must be 4 years old by December 1, 2020)

3-Day Program - \$85.00 Registration Fee + \$260.00 September Deposit = \$435.00 due at Registration

Mon / Wed / Fri 9:30 am – 12:00 noon \$260.00 per month Mon / Wed / Fri 1:00 – 3:30 pm \$260.00 per month

5-Day Program - \$85.00 Registration Fee + \$350.00 September Deposit = \$435.00 due at Registration

Mon to Fri 1:00 – 3:30 pm \$350.00 per month

#### Mommy and Me (For 12 – 23 mos) - Use separate form for Mommy & Me Registration

3 Sessions: Fall, Winter, and Spring–8 weeks per session
Wednesdays
9:30 – 10:30 am

Tuition due by 1st Class of the session
\$120 (No Registration Fee)

- Tuition discounts are given to any family enrolling more than one child in our preschool during the same school year as follows: full tuition is paid for the first child and there's a \$20 tuition discount for each additional child. There are no sibling discounts offered on the Registration Fee. Discount does not apply to Tiny Tots Class.
- Enrollments are considered for the entire year. No refunds for tuition will be granted for the temporary removal of a child from school. We must receive written notice by the first of the preceding month if a child is to be withdrawn from the program.

# II. Requirements for Registration

- All Enrollment payments are non-refundable.
- Separate registration forms must be completed for each child enrolled.
- To enroll any student you must pay the registration fee plus prepay September's tuition deposit.

# III. Procedures for Registration

#### **Before Registration**

- Read all the information given to you and take note of the registration dates applicable to your case.
- Complete and sign the Registration Form and Financial Agreement, one for each child you are enrolling.

#### **At Registration**

- You must submit your completed and signed Registration Form and Financial Agreement with your payment of the Registration Fee + September's tuition deposit.
- Spots will be filled on a first come, first served basis immediately upon receipt of the completed and signed registration form, financial agreement and payments.
- You must present your child's birth certificate for verification.

# **After Registration**

- Other forms such as Health Forms, Emergency Forms and Student Questionnaire will be mailed to you during the summer. These forms must be completed before the child begins school.
- To comply with New York State mandate your child CANNOT begin school until a complete immunization record and current physical examination, both signed by the child's physician, are submitted.

- ➤ Teacher placement will be offered on a first come, first served basis.
